#### ADMINISTRATION PRESENT.

#### APRIL 10, 2013 REGULAR MEETING MINUTES.

A motion made by Loxley and seconded by Summers was passed unanimously to approve the April 10, 2013 Regular Meeting minutes.

#### APRIL TREASURER'S REPORT.

A motion made by Summers and seconded by Loxley was passed unanimously to approve the April Treasurer's Reports.

#### ROADMASTER REPORT.

Bob Summers, Roadmaster, said SWEPI, LP is done rebuilding T371 Job Corps and T358 Beaver Meadows Roads. He said he inspected it and they had done a very good job. He said all of the roads have been graded. Summers said he was trying to find someone to apply salt brine to the roads for dust control.

### CODE ENFORCEMENT REPORT.

Marjorie Villarreal, Code Enforcement Officer, said she permitted two companies for three months each for over weight vehicles on the township roads. She said Bald Hill Oil received a permit to travel on T374 Sheffield Junction Road and North East Hardwoods got one for T358 Beaver Meadows Road. She said she received a building permit application from Jeffrey Terzolino for an 8' x 8' room addition at his seasonal residence off of Route 666. She said Herman Corbett applied to build a 12' x 37' addition to their mobile home on Richard Shick's property on T333 Bean Farm Road.

#### HIGHWAY MATERIAL SUPPLIES SEALED BIDS.

A motion made by Summers and seconded by Loxley was passed unanimously to award the highway material supplies to the lowest bidders.

400 ton of DSA tailgated and spread by 5/31/2013 was awarded to Jefferson Paving Corporation at \$28.18 per ton totaling \$11,272.00, 100 ton DSA delivered to the garage by 6/30/2013 was awarded to Jefferson Paving at \$28.18 per ton totaling \$2818.00, 100 ton #8 anti skid delivered to the garage by 8/31/2013 was awarded to IA Construction Corporation at \$20.60 per ton totaling \$2060.00, 3000 gallons of MC70 applied and covered with #8 aggregate by 7/1/2013 was awarded to Suit-Kote Corporation at \$4.00 per gallon totaling \$12,000.00 and 3700 square yards of Double Bituminous Seal Coat applied by 8/31/2013 was awarded to Jefferson Paving Corporation at \$3.08 per unit totaling \$11,396.00.

Other bids were as follows: Jefferson Paving bid \$27.68 per ton for the #8 anti-skid totaling \$2768.00, for the MC-70 Oil applied and covered with #8 aggregate Russell Standard Corporation bid \$4.48 per gallon totaling \$13,446.00 and Jefferson Paving bid \$6.06 per gallon totaling \$18,180.00 and for the Double Bituminous Seal Coat Suite-Kote bid \$8.00 per unit totaling \$29,600.00, Russell Standard bid 3.92 per unit totaling \$14,515.10 and Glenn O. Hawbaker Inc. bid \$4.75 per unit totaling \$17,575.00.
