The meeting was called to order and the Pledge of Allegiance recited. Guests present for the 3:00 PM sealed bid opening were Stan O'Rourke and Pat Traut, Vice President, Russell Standard Corporation. Dolores Loxley was the only guest present for the 5:00 PM special meeting.

BEAN FARM ROAD, T333, DRIVEWAY CULVERT.

A motion made by Summers and seconded by Loxley was passed unanimously to discuss sending a letter to the owners of two seasonal cabins on T333 Bean Farm Road that share a driveway and ask them to meet with the Supervisors to talk about the stormwater discharge damage problem the driveway is causing.

REMOVAL OF TREES PAYMENT.

A motion made by Summers and seconded by Loxley was passed unanimously to pay Zimmerman Lumber \$2940.00 for the removal of trees inside the township right-of-way.

GARAGE PURCHASE.

A motion made by Summers and seconded by Loxley was passed unanimously to replace the purchase of an oil drum rack in the budget and purchase in its place a 55 gallon drum of 15/40 oil for \$575.00.

HIGHWAY SUPPLIES AWARDED.

A motion made by Summers and seconded by Polovich was passed unanimously to award the following bids: 7581 gallons of MC70 applied and covered with #8 limestone aggregate to Russell Standard Corporation for \$4.363 a gallon totaling \$33075.90, 3940 square yards of single bituminous seal coat to Jefferson Paving Corporation for \$1.43 per square yard totaling \$5634.20 and 5950 square yards of double bituminous seal coat to Jefferson Paving Corporation for \$2.43 square yard totaling \$14458.50. Other bids for the MC70 were Glenn O. Hawbaker bidding \$5.935 per gallon totaling \$44993.24, Suit-Kote Corporation bid \$5.79 per gallon totaling \$43893.99 and Jefferson Paving bid \$4.79 per gallon totaling \$36312.99.

HIGHWAY SUPPLIES AWARDED CONTINUED.

Other bids for the single seal were Hawbaker bidding \$1.573 per sy totaling \$6197.62, Suit-Kote bid \$2.16 per sy totaling \$8510.40 and Russell Standard bid \$1.687 per sy totaling \$6646.78 and for the double seal Hawbaker bid \$3.448 per sy totaling \$20515.60, Suit-Kote bid \$3.10 per sy totaling \$18,445.00 and Russell Standard bid \$2.634 per sy totaling \$15,672.30.

Chairman Summers adjourned the meeting at 5:25 PM.
